**Application for a premises licence under the Licensing Act 2003
Premises: Watton Sports Centre, Dereham Road, Watton**

Further to my telephone call as discussed I am writing as I have been passed a copy of your application to comment upon from an environmental health perspective.

I have some concerns regarding the application due to the provision of outside dance, live and recorded music and the effects that it may have on nearby residents. While these activities are not subject to any licence conditions for events held on licensed premises between the hours of 08:00 and 23:00 and where audiences numbers are less than 500, should an event be held where numbers exceed 500 or at a time when the premises is not open for the sale or supply of alcohol for consumption on the premises this would not be the case.

Therefore I propose the following:

- The premises shall not generate noise, measured as an LA10, which exceeds the representative background noise level LA90 (level exceeded 90% of the time), by more than 5dB. The noise level should be measured at the boundary of the premises. The LA90 and LA10 shall be measured using the principles contained in BS4142 and shall be measured over 1 hour between the hours of 7am and 7pm and over 15 minute periods between the hours of 7pm and 7am. The noise level should apply between the hours of 18:00 and 08:00 at all times when regulated entertainment takes place.

All measurements to be taken with a sound level meter of IEC 651 Type 1, or BS EN 61672 Class 1, standard (or the equivalent relevant UK adopted standard in force at the time of the measurements) set to measure using a fast time weighted response. This should be calibrated in accordance with the procedure specified in BS 4142: 1997 (or the equivalent relevant UK adopted standard in force at the time of the measurements)

- Outdoor live or recorded music will not take place after 23:00

If you are in agreement with these amendments please complete the form overleaf and return to me at this office as soon as possible. If, however, you are not in agreement with these amendments, the decision will go to a hearing of which you will be notified by the licensing team.

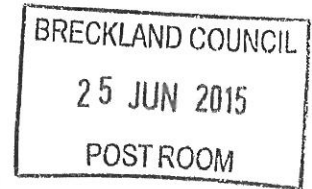
