The NCC Highways Officer has given the following response:

The indicative improvement details shown on Drawing C100 P3 are acceptable in principle. However the works will require the approval of the LLFA regarding the ditch piping and also Cadent regarding the effect of the surfacing on the Gas Main. I have flagged up to the applicant's highway consultant that the protection of the Gas Main may come at considerable cost and he has advised me that he has been in discussion with Cadent in this respect. We still do not have the written approval of the LLFA concerning the ditch piping and I will leave it to you to decide whether permission can be granted without this since there is no guarantee approval will be forthcoming. The internal access road will not be considered for adoption and consequently does not need to have separate footway provision. If you are minded to grant approval full details of the internal access road, parking, a size 3 communal turning head and a Construction Traffic Management Plan will need to form part of any reserved matters submission with the following conditions and informative notes being imposed at this stage.

SHC 32A

Notwithstanding the details indicated on the submitted drawings no works above slab level shall commence on site unless otherwise agreed in writing until detailed drawings for the off-site highway improvement works as indicated on Drawing No. C100 P3 have been submitted to and approved in writing by the Local Planning Authority.

Reason: To ensure that the highway improvement works are designed to an appropriate standard in the interest of highway safety and to protect the environment of the local highway corridor.

SHC 32B

Prior to the first occupation of the development hereby permitted the off-site highway improvement works referred to in Part A of this condition shall be completed to the written satisfaction of the Local Planning Authority.

Reason: To ensure that the highway network is adequate to cater for the development proposed.

SHC 05

Prior to the first occupation of the development hereby permitted the vehicular access crossing over the verge and ditch shall be constructed in accordance with a detailed scheme to be agreed in writing with the Local Planning Authority in accordance with the highways specification TRAD 1 and thereafter retained at the position shown on the approved plan. Arrangements shall be made for surface water drainage to be intercepted and disposal of separately so that it does not discharge from or onto the highway.

Reason: To ensure construction of a satisfactory access and to avoid carriage of extraneous material or surface water from or onto the highway in the interests of highway safety.

SHC 16

Prior to the first occupation of the development hereby permitted visibility splays measuring 2.4. metres x 59. metres shall be provided to each side of the access where it meets the highway. The splays shall thereafter be maintained at all times free from any obstruction exceeding 0.6 metres above the level of the adjacent highway carriageway.

Reason: In the interests of highway safety in accordance with the principles of the NPPF.

This development involves work to the public highway that can only be undertaken within the scope of a Legal Agreement between the Applicant and the County Council.
