Subject: Annual Report on the Treasury Management Service and Actual Prudential Indicators 2018/19

Purpose: The Council is required through regulations issued under the Local Government Act 2003 to produce an annual treasury report reviewing treasury management activities and the actual prudential and treasury indicators for 2018/19. This report meets the requirements of both the CIPFA Code of Practice on Treasury Management (the Code) and the CIPFA Prudential Code for Capital Finance in Local Authorities (the Prudential Code).

Recommendation(s):

1.0 BACKGROUND

1.1 During 2018/19 the minimum reporting requirements were that Governance and Audit Committee should receive the following reports:

- An annual treasury strategy in advance of the year (Governance and Audit Committee 16th February 2018)
- A mid year (minimum) treasury update report (Governance and Audit Committee 14th December 2018)
- An annual review following the end of the year describing the activity compared to the strategy (this report)

The regulatory environment places responsibility on Members for the review and scrutiny of treasury management policy and activities. This report is therefore important in that respect, as it provides details of the outturn position for treasury activities and highlights compliance with the Council's policies previously approved by Members.

To support Members scrutiny role, Member training on treasury management takes place annually. However, as reported to Governance and Audit committee 15th February 2019, training has been delayed until after the elections in May.

An update from Link Asset Services, the Councils Treasury Management Advisors, on the economy and interest rates is attached at Appendix A, for information purposes.

As reported to Governance and Audit Committee 14th December 2018 and 15th February 2019, new guidance was implemented in 2018/19 effective in full from 1st April 2019. The

Council's Treasury Management Policies and Prudential Indicators have been more closely aligned to the Council's Capital strategy and have been amended to include both a definition of and a schedule of financial and non-financial investments. New indicators have been added to the Treasury Management Strategy for 19/20 to ensure the same robust procedures for the consideration of risk and return are applied to both financial and non-financial investments. As these indicators are new for 19/20, they are not covered in this outturn report but will be included in future reports to Governance and Audit Committee.

2.0 OVERALL TREASURY POSITION AT 31ST MARCH 2019

During 2018/19, the Council complied with its legislative and regulatory requirements. The key actual prudential and treasury indicators detailing the impact of capital expenditure activities during the year, with comparators, are as follows:

NB: The 18/19 investments total excludes loans to Breckland Bridge which fall outside of the treasury reporting requirement. However, no capital loans were outstanding at 31/3/2019. These loans enhance the Council's investment return. (Further details are shown in Appendix B).

Other prudential and treasury indicators can be found at Appendix B. The Executive Director Commercialisation also confirms that no borrowing was undertaken for a capital purpose and the statutory borrowing limit (the authorised limit) was not breached.

The financial year 2018/19 continued the challenging investment environment of previous years; low investment returns and higher levels of counterparty risk.

At 31 March 2019, the Council's external debt was Nil (Nil at 31 March 2018) and its investments totalled £23,406k (£23,973k at 31 March 2018).

A copy of the 2018/19 treasury performance report is shown at Appendix C for information.
