**PROCEDURE FOR THE
LICENSING PANEL**

1. Chairman introduces the Officer(s) and explains procedure to parties present.
2. Presentation by Officer(s) (This should be a factual report and should not contain recommendations for grant or refusal etc.)
3. Questions to Officer(s) by Members on Policy etc.
4. Presentation by Applicant (opening, call witnesses and produce documents relevant to application).
5. Questions to Applicant by Members.
6. Interested parties/ Responsible Authorities may question Applicant.
7. Presentation by Interested Parties / Responsible authorities (opening, call witnesses and produce documents relevant to the representations made and the licensing objectives).
8. Questions to Interested Parties/ Responsible Authorities by Members.
9. Questions to Interested Parties/Responsible Authorities by Applicant.
10. Summary by Applicant.
11. Advice from Officer(s) on policy and/or Solicitor on law and jurisdiction.
12. Members retire from hearing accompanied by the Democratic Services Officer to consider the matter (They may call in Solicitor to help draft reasons for decision. Any other advice must be repeated in open forum).
13. Members return and the decision, including reasons, is announced. The decision and reasons will be provided to all parties in writing within 5 working days of the hearing.

Notes

All parties will be allowed an equal amount of time to present their case. In normal circumstances, the Panel will expect each party to present their case within a maximum of 20 minutes, although this time limit may be varied by the Panel, either on the application of a party to the hearing or at the Panel's own instigation. Where there are a number of interested parties whose representations reveal similar grounds of concern, the interested parties are strongly urged to appoint a spokesperson from amongst their number, in order that hearings are not unnecessarily lengthened by the repetition of the same points.

The Panel will be clerked by a Solicitor and a representative from Democratic Services who will produce a record of the hearing, the decision and reasons of the Panel. No decision should be publicly delivered without first obtaining legal advice. Members may ask for legal advice at any time to assist them in discharging their responsibilities. This should ordinarily be done at the meeting except when Members retire to make their decision.

Where applicants, Interested Parties, or Responsible Authorities intend to call witnesses at the hearing, the name of the witness and a brief summary of the points to be raised by them shall be supplied to the Licensing Authority. This summary together with the application and the representations received shall be combined into the report. A notice of hearing shall be given no later than 10 working days before the day of the hearing.

Recommendation(s):

- 1) That the members of the Licensing Panel determine the application for the grant of a new premises licence at Bucharest Supermarket Ltd, 42 King Street, Thetford, Norfolk, IP24 2AP

1.0 BACKGROUND

- 1.1 The licensing authority accepted an application for the grant of a premises licence under the Licensing Act 2003 on 7th February 2022 with an end date for representations of the 7th March 2022. A copy of the application is attached as **Appendix A**.
- 1.2 The application requests the following licensable activities

Sale of alcohol (Off Sales)

Monday to Sunday 08:00 to 22:00 hours

- 1.3 We received representation from two Responsible Authorities: Norfolk Trading Standards and Norfolk Constabulary. These responses can be seen as **Appendix B (Restricted)**. It should be noted these representations are in regard to the licensing objective for the prevention of crime and disorder and are restricted due to confidential and sensitive information.

2.0 OPTIONS

- 2.1 As they consider it appropriate for the promotion of the licensing objectives, the Panel of the Committee of the Licensing Authority in accordance with Section 18 of the Licensing Act may:
 - a. Grant the licence subject to such conditions as are consistent with the operating schedule accompanying the application
 - b. Modify the conditions of the licence, altering or omitting or adding to them.
 - c. Exclude any of the licensable activities which the application relates
 - d. Refuse to specify a person in the licence as the premises supervisor
 - e. Reject the application

The licensing Panel are asked to note that they may not reject the application merely because it is desirable to do so. It must actually be necessary in order to promote the licensing objectives.

Members of the Licensing Panel are asked to make a decision at the end of the hearing after all parties have been given the opportunity to speak. Members must give full reasons for their decision.

3.0 REASONS FOR RECOMMENDATION(S)

3.1 The application must be considered in accordance with the Licensing Act 2003 and subsequent regulations, the guidance is issued under section 182 of the Licensing Act 2003, Breckland Council's Statement of Licensing Policy and representations to ensure that a lawful decision is made.

b) The prevention of crime and disorder

CCTV will be installed and operating internally and externally and will cover all public areas where licensable activity takes place whilst the premises is open to the public. The time and date will be set to the correct time relating to BST/ GMT. A competent trained person in the use of and operation of the CCTV will be in attendance at the premises at all times that licensable activities take place and will be able to fully operate the CCTV system to be able to down load at the time of the visit in a recognised format any information requested by the Police or Responsible Authority. All CCTV images will be retained for a period of not less than 31 days and any evidential incidents will be down loaded and stored in a secure system until such time as collected by an appropriate authority. An incident register of all occurrences inside the premises will be maintained at the premises and any details of any incidents of crime and disorder will be recorded. The register will be produced and made available at the time of the visit for inspection upon request by any Responsible Authority. No alcohol or tobacco will be purchased from sellers calling at the premises. Exceptions to the condition would be purchases made from authorised representatives who have made prior appointments to visit the store. All alcohol and tobacco products sold at the premises will have the relevant UK duty paid. Foreign tobacco, which does not comply with relevant UK legislation, will not be stored or sold at the premises. Invoices, or copies of invoices, for all alcohol and tobacco purchases for the sale at the premises, will be retained and kept at the premises and also made available to officers from Trading Standards, the Police or HMRC, upon request. A stock control system will be maintained to enable the designated premises supervisor to quickly identify where and when alcoholic and tobacco products have been purchased. If any tobacco products purchased for or on behalf of the business does not have UK Duty Paid fiscal mark or are otherwise suspicious, the designated premises supervisor will notify the supplier to Breckland Council Trading Standards and HMRC within 48 hours and the products will not displayed for sale.

The register will contain details of the staff member refusing the sale and will be checked on a two weekly basis by the Designated Premise Supervisor and also signed and dated by the Designated Premises Supervisor. The refusal register will be produced and made available for inspection at the time of the visit by any Responsible Authority. All persons involved in the sale of alcohol/ age restricted products will receive initial and regular six monthly refresher training by the Designated Premises Supervisor, with regards to the law in relation to the sale of alcohol/ age restricted products. Such training will be recorded and up to date training records of all such persons will be maintained at the premises and produced and made available for inspection at the time of the visit by any Responsible Authority. Records for each person will be retained for a minimum of twelve months.
