ANNEXES

Annex 1 - Mandatory Conditions

1. No supply of alcohol may be made under the premises licence at a time when there is no designated premises supervisor in respect of the premises licence, or
2. No supply of alcohol may be made under the premises licence at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
3. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
4.
 - (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
5. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

Annex 2 - Conditions consistent with the operating schedule

1. A Challenge 25 or similar age verification policy shall be in operation at the premises together with an age verification training scheme for staff. Staff training shall consist of underage sales, checking ID, proxy sales, basic conflict management and relevant areas of the Licensing Act 2003 with penalties for breach. Refresher training shall be carried out every 12 months. All staff training records shall be stored on the premises and available for inspection by Authorised Officers.
2. Age Verification policy notices shall be displayed in prominent positions in the shop.
3. The premises shall also maintain an ID Signature log book as additional support. All refusals of the sale of alcohol to suspected underage / drunk people shall be entered in a refusals log book.
4. Signage regarding proxy sales shall be displayed near the alcohol sales areas.
5. CCTV shall be installed at the premises to cover the internal customer area and the front external area of the premises. A CCTV camera shall be positioned to capture a good quality head and shoulder image of the customer. The CCTV equipment shall be maintained to the standard of the Norfolk Police Policy. All images shall be retained for a minimum of 28 days on hard drive and be made available on request to Authorised Officers.
6. Spirits of high ABV shall be stored and sold behind the counter.

7. When the DPS is not on duty a contact telephone number shall be available at all times.
8. Records of any incidents shall be recorded in an incident log. The premises shall operate and record all incidents of criminal activities, anti-social behaviour and injuries to persons using the relevant log books. All log books shall be fit for purpose and shall be retained on the premises for 12 months.
9. Notices shall be clearly displayed asking customers to leave the area quickly and quietly.
